The University of Utah Financial Aid & Scholarship Office and the S.J. Quinney College of Law cooperate to assist students and their families in meeting the costs of law school. The College of Law has a limited number of need-based scholarships that are intended to assist those students who demonstrate the greatest amount of substantiated need that is not otherwise met by available loans, fellowships or other scholarships. A student's financial need is the difference between what the college estimates it would cost to attend law school and what the student is expected to provide to meet the cost of attendance.

The University of Utah uses the information provided through the Free Application for Federal Student Aid (FAFSA) for determining financial need. Students will not have their need-based financial aid processed through the University or the College of Law without first filing a FAFSA or Renewal Application and listing the University of Utah in the FAFSA as a university you plan to attend. In making its need-based scholarship awards, the College of Law will consider estimated family contribution ("EFC") as calculated by the FAFSA processor, loan award eligibility and other factors - such as other scholarships received, family, or military benefits. You may also attach additional statements or documents in support of this application for a need-based scholarship. Need-based scholarships are not available for summer term, visiting away from the University of Utah S.J. Quinney College of Law, students registered for less than 11 credits per semester, or to meet additional costs associated with the College of Law London study abroad. Students not picking up need-based disbursements by the last day of classes for a semester forfeit that semester's disbursement.
