

# FREE LEGAL CLINICS

The purpose of our pro se legal clinics is to provide brief one-on-one instruction and assistance to **low-income Utahns who cannot afford legal representation**. For example, at a clinic you could learn where/when to file papers and which documents you'll need in order to proceed. Ultimately, you must make all of the decisions and file documents on your own. Clinic volunteers **CANNOT** file for you. Clinic volunteers **CANNOT** appear in court on your behalf.

**We do not offer legal representation...only brief instruction and assistance.**

The Legal Clinics run on a first come, first served basis only. We do not make appointments. We strongly suggest that you bring someone with you who can interpret, as interpreters are not always available.
